Council approved this proposal and expressed that it was a good initiative to conduct this course by central office as many CI/OCC do not have resource persons to teach module A & B of this course.

2.3 HBNI-Industry Linkage Cell

Prof. Naik informed the members about the recent initiative of HBNI regarding internship of HBNI Ph.D. students upto 6 months in Industrial R&D laboratories so that skill and job opportunities are created for interested students. He mentioned that this initiative is in the line of recommendations by UGC as well as NEP-2020 to take appropriate measures to form linkage with industries for the mutual benefits. He explained that HBNI has taken the initiative and proposed to form a HBNI-Industry Linkage Cell. The Cell will facilitate internship at industry, research collaboration between HBNI faculty and R & D centers of industry and consultancy to industry by superannuated faculty members and other domain experts from DAE. He highlighted the key aspects of the scheme (Annexure-3) and sought suggestions of the council. VC added that academic extension may be permitted for the time duration of internship. However, no fellowship will be provided by DAE during internship and it should be covered by the Industry. He also informed that some Industrial organisations have expressed keen interest to accept doctoral students from HBNI for such internship.

The Council welcomed the proposal for enhancing interactions with industry and also approved the proposal to provide an academic break of upto 6 months to Ph.D students of HBNI to engage with industry in an appropriate format. HBNI will work out a detailed scheme for the same and obtain approval of Council of Management.

2.4 Revision of Academic ordinances

Prof. B. K. Dutta, HBNI informed the council that the last version of Academic Ordinances was issued in December 2018 after discussions at several stages. Since then UGC has issued many new circulars and guidelines. HBNI has also introduced many new academic programs. Hence, the revision of academic ordinances is required. The process has been started and in due course of time it will be placed before Academic Council for suggestions. Finally, approval of CoM will be sought. Prof. Dutta informed the Council that inputs for the updating the ordinances have been sought from Deans (Academic). He requested that the inputs may be expedited so that the work of revision of the ordinances could be taken up at the earliest.

Academic Council agreed to the proposal.

2.5 HBNI Affiliation in Publications

Prof. Vasudeva Rao informed that as per the previous recommendations of Academic Council, affiliation of HBNI by its faculty members and students are cited by one of the two options – Option-1: 'full form of HBNI'; Option-2: only 'HBNI' (as shown in Annexure-4). To have the uniformity in the HBNI publications and also to satisfy the requirements of various statutory bodies, it is proposed that in all future publications, HBNI affiliation may be cited as per Option-1.
