Sealed quotations are invited on behalf of the Vice Chancellor, HBNI for "**Fabricating Two Cabins in Room No. 204 at HBNI**" as per specifications in the attached Annexure-A and terms and conditions mentioned below:

- 1) Sealed quotations should be submitted either by post or person to the HBNI's Central Office, 2nd Floor, Training School Complex, Anushaktinagar, Mumbai 400 094 HBNI latest by **18.02.2022 at 15.00 hrs.**
- 2) Quotations should be placed in sealed envelope super scribing Tender for "**Fabricating Two Cabins in Room No. 204 at HBNI**" and last date of submission of tender.
- 3) The quantities are tentative and it can be reduced or increased as per requirement.
- 4) Bidders should also have experience in work such as modification, fabrication & repairs of similar works.
- 5) The amount of each item should be worked out and the requisite totals given.
- 6) The validity of the quotations shall be for a minimum period of 30 days from the date of opening of the quotations.
- 7) The rate shall be inclusive of GST / taxes but should be shown separately.

8) **Period of completion**

The entire works should be completed within a period of **21** days which will be reckoned from the date of issue of work order.

- 9) **Warranty/Guarantee:** The items under this quotation shall be guaranteed for satisfactory performance against manufacturing defects and faulty workmanship for a period of **12 months** from the date of final acceptance. If the item becomes defective during this period, the contractor shall be responsible for making arrangement for repair/replacement at his own cost.

- 10) **Payment:** 100% payment together with statutory levies shall be made within 30 days of receipt and final acceptance of the material ordered & on submission of satisfactory installation and commissioning certificate issued by the purchaser. Income Tax, as applicable, shall be recovered from the bill.

- 11) **Liquidated Damages:-** The date of delivery of the stores stipulated in the Contract shall be deemed to be the essence of the contract and the delivery & installation must be completed not later than the date specified. If the Contractor fails to deliver the stores within the period specified, the purchaser shall be entitled to recover from the Contractor through **Liquidated Damages** and not by way of penalty, a sum of 0.5% per week or part thereof to a maximum of 10% of the total cost will be applicable in case of delay in satisfactory completion of work.
- 12) **Security Deposit**
- 3% of the gross amount of the bill shall be submitted as Performance Guarantee in the form of Bank Guarantee from Nationalized/Scheduled Banks & 2.5% as Security Deposit. The Security Deposit will be refunded after the defective liability period is over.
- 13) Quotations submitted by Vendors who are Blacklisted by any Government Organisation, will not be entertained and are requested to refrain from submitting the tender.
- 14) HBNI reserves the right to accept or reject any or all the tenders invited/received, without assigning any reason thereof.
