Sub.: Research publications and communications using the name as in Enrolment and certificate from the Guide – reg.

1. In all the scientific publications & communications, students should use the same name as it is enrolled in HBNI. Using the initials for the first/middle/last names and the change of their positions may be alright, but no addition and/or deletion of any of those is acceptable.

2. Journal publications/book-chapters/conference papers resulted from the Ph.D. thesis work should be clearly indicated in the list of publications provided during

synopsis/thesis submission.

3. There should be a "Certificate from the Guide on Publications", mentioning the following points clearly while submitting the synopsis:

(i) Student's contribution in the publication as well the part of the work in the publication that has been included in the thesis.

(ii) Certifying that the co-authors of the publications have no objection in including a part or full work thereof in the thesis.

(iii) Certifying that the part of the work already included in the thesis will not be included again in any other thesis.
