- To update their academic records, and records of all their events organised under the auspices of HBNI.
- Compilation of BoS approved courses for this period.
- Compilation of awards won by faculty members and students
- To conduct /submit report on Green Audit, Energy Audit, Quality Audit, and Environmental Audit as a part of SSR required for NAAC accreditation.
- Geo-tagged photos of various facilities utilised by faculties and students.

Accordingly, all CIs and OCCs may kindly take note of the above for compliance and inform the details of NAAC Co-ordinator of the CI/OCC, to the undersigned latest by 30th September 2025.
