1. This Cell will also function as Complaints Committee to inquire into the complaint of Sexual harassment of women.
2. This Cell will look into the complaints made by female students of HBNI.
3. Any complaint of sexual harassment should be forwarded by the student to this committee only after it has already been examined and investigated by the corresponding cell in the CI/OCC and if the student is not satisfied with the outcome.



4. Depending upon the Constituent Institution/Off-Centre Campus (CI/OCC) at which the student is enrolled the committee will co-opt a nominee of the CI/OCC, to be decided by the Dean (Student's Affairs) of the concerned CI/OCC in consultation with the Director of CI/OCC.
5. If the complaint is made against the staff member of the CI/OCC, the committee will forward its recommendations to the Competent Authority in the CI/OCC for administrative actions as necessary.
6. If the complaint is made against fellow student, the committee will forward its recommendations to the Competent Authority in HBNI for further actions.
