NOTIFICATION

No.10-3/2025-U.3(A): Whereas, Homi Bhabha National Institute (Institution deemed to be University), Mumbai had uploaded its application on UGC Portal to start an off-campus Centre at Plot No. 1, Medicity, New Chandigarh, District – SAS Nagar (Mohali), Punjab as per the UGC (Institutions deemed to be Universities) Regulations, 2023.

- 2. **And whereas**, UGC, vide its letter No. 30-6/2024 (CPP-I/DU) dated 02.01.2025, informed that the Chairman, UGC constituted a Standing Committee to examine the application. The Committee, after presentation of the Institution and based on the documents submitted, recommended for issuance of Letter of Intent (LoI) to Homi Bhabha National Institute, Mumbai with certain conditions.
- 3. **And whereas**, the Ministry, on the advice of UGC, issued Letter of Intent (LoI) dated 21.01.2025 to Homi Bhabha National Institute, Mumbai for fulfillment of the certain conditions within a period of 3 years before starting of off-campus at Plot No. 1, Medicity, New Chandigarh, District SAS Nagar (Mohali), Punjab.
- 4. **And further whereas**, Vice Chancellor, Homi Bhabha National Institute, Mumbai, vide his letter dated 18.02.2025, submitted compliance report in respect of fulfillment of the conditions of the LoI. The same was forwarded to IIGC for verification and further advice. UGC, vide letter No. F. 30-6/2024 (CCPP-I/DU) dated 18.03.2025, conveyed that the compliance report was accepted by the Standing Committee.
- 5. **Now, therefore**, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Ministry of Education, on the advice of UGC, hereby accords approval to Homi Bhabha National Institute, Mumbai to start an off-campus Centre at Plot No. 1, Medicity, New Chandigarh, District SAS Nagar (Mohali), Punjab with condition that the students shall be admitted in the professional courses only after approval of relevant statutory councils.

6. Homi Bhabha National Institute, Mumbai shall abide by all other conditions mentioned in the earlier Notification(s) of this Ministry as well as provisions of the Rules / Regulations of UGC and other Statutory Councils, issued from time to time.
